CREDIT TERMS

INVOICES ARE DUE AND PAYABLE 30 DAYS FOLLOWING THE INVOICE DATE (NET 30). ANY INVOICES WHICH BECOME PAST DUE AFTER THIS TIME WILL BE ASSESSED A 2% PER MONTH LATE CHARGE.
ANY PAYMENTS MADE WITH A CREDIT CARD WILL BE SUBJECT TO A 3% HANDLING FEE.
ANY ACCOUNT WHICH FAILS TO MAKE PAYMENT PER THE TERMS LISTED ABOVE WILL BE PLACED ON A C.O.D. BASIS IMMEDIATELY. IF PAYMENT IS NOT RECEIVED WITHIN SIXTY (60) DAYS, THAT ACCOUNT WILL BE REFERRED TO A COLLECTION AGENCY OR FOUR CORNERS WELDING & GAS SUPPLY'S CORPORATE ATTORNEY. ALL FEES INCURRED FOR THE COLLECTION OF PAST DUE ACCOUNTS WILL BE THE RESPONSIBILITY OF THE DEBTOR.
ANY ACCOUNTS PAID WITH CHECKS THAT ARE DECLARED NOT PAYABLE BY THE CUSTOMER'S BANK, WILL BE TREATED AS PAST DUE AND WILL BE SUBJECT TO A PENALTY FOR INSUFFICIENT FUNDS AT THE RATE USED BY FOUR CORNERS WELDING & GAS SUPPLY AT THE TIME THE CHECK DOES NOT CLEAR. THAT ACCOUNT WILL THEN BE CONSIDERED FOR C.O.D. STATUS WITH LOSS OF CREDIT PRIVILEGES. AFTER REASONABLE COLLECTION ATTEMPTS, ACCOUNT AND INSUFFICIENT CHECKS MAY BE TURNED IN TO THE DISTRICT ATTORNEY OR SHERIFF'S OFFICE FOR PROSECUTION AND COLLECTION.
BUYER IS RESPONSIBLE FOR SELLER'S (FOUR CORNERS WELDING & GAS SUPPLY'S) CYLINDERS AND EQUIPMENT, INCLUDING VALVES AND CYLINDER CAPS, WHILE IN THE BUYER'S POSSESSION, AND MUST RETURN ALL SELLER'S CYLINDER'S IN THE SAME CONDITION AS RECEIVED (REASONABLE WEAR AND TEAR EXCEPTED); FAILURE TO DO SO CONSTITUTES A BREACH OF THIS CONTRACT AND BUYER SHALL BE LIABLE FOR THE COST OF REPLACEMENT OR REPAIR OF EACH CYLINDER NOT RETURNED OR DAMAGED.
SELLER RESERVES THE RIGHT TO CHARGE RENTAL ON ALL CYLINDERS IN THE BUYER'S POSSESSION. RENTAL IS CHARGEABLE AT THE STANDARD RATES SET FORTH IN SELLER'S PRICING SCHEDULE FOR COMMODITIES.
CLAIMS BASED ON DEFECTIVE VALVES OR CYLINDERS ARE WAIVED UNLESS MADE WITHIN THREE (3) DAYS AFTER SHIPMENT AND CYLINDER IS RETURNED TO SHIPPING WAREHOUSE WITH TAG STATING DEFECT.
THE BUYER SHALL NOT LOAN OR REFILL OR CAUSE TO BE LOANED OR REFILLED THE CYLINDERS FURNISHED BY THE SELLER. BUYER MUST SURRENDER, UPON DEMAND, RENTAL CYLINDERS BELONGING TO FOUR CORNERS WELDING & GAS SUPPLY IF RENTAL PAYMENTS ARE PAST DUE.
Seller, not being the manufacturer of the leased equipment, nor the manufacturer's agent, makes no warranty or representation, either express or implied as to the fitness, design or condition of, or as to the quality or capacity of the material, equipment or workmanship in the leased equipment, nor any warranty that the leased equipment will satisfy the requirements of any law, rule, specification or contract which provided for specific machinery or operator, or special methods, it being agreed that all such risk, as between seller and buyer are to be borne by buyer at its sole risk and expense.

This guarantee is unlimited in amount and is a continuing guarantee of each and every debt or obligation incurred by or owing from Debtor to FCWGS either at the date hereof or at anytime hereafter during the term of this guarantee. The undersigned may revoke its guarantee hereunder (without affecting the obligations of any other guarantor hereunder), such revocation to be effective five (5) days after receipt by the Credit Department of FCWGS of written notice of revocation of the undersigned. Revocation shall, however, in no way terminate or otherwise affect any obligation hereunder of the undersigned existing on or prior to the effective date of such revocation with respect to transaction between FCWGS and Debtor commenced prior to such effective date even though consummated thereafter, including without limitation, accrued interest, late payment penalties and costs of collection, including reasonable attorney fees.

Renewal or extensions of time of payment or performance or any other modification, compromise or forbearance of any indebtedness or obligation of Debtor, or any release, addition, to or change of security for any such indebtedness or obligation, and any change in the form of indebtedness from open book account to notes or otherwise, by FCWGS are hereby agreed and consented to by the undersigned.
